It has been reported that The Star Casino (Sydney, Australia) will shed 100 key management jobs in the wake of a scandal as it desperately seeks to rebuild its tattered reputation. The biggest head to roll is the Chief Financial Officer in this mammoth shake-up.

The purge comes after months of bad publicity and declining profits at The Star. The casino has issued two profit warnings this month. Turnover for 2012 is expected to be as low as \$A270m, down from \$A347m in 2011.

Echo Entertainment Group holds the only Casino licence in Sydney, which is not due for renewal until 2017. In recent months there has been some interest in this company, coming from two very successful gaming companies, *Crown Casinos and Gentings Holding (HK)*, both of which have major gaming holdings around the world.
