992 - Revitalization Initiative Update

The Revitalization Initiative has continued to gain traction through the early summer. The work of Mr. Ron Ko & Ms. Diane Gartshore – Directors (OLG) in pushing forward on the key elements prior to launch into market has been tremendous and they deserve full credit. This Association (CGAO) and that of our Charity Association (OCGA) have been equally committed through the summer in ensuring we support the initiative totally to meet the targeted launch dates.

The recent announcement of Mr. George Sweny, Senior Vice President (Charitable & iGaming), who undertook his position last week, has been <u>a critical piece</u> to ensure focused *Senior Leadership* to our file. There are only a few individuals in the country that could step into a senior position of this nature and *hit the ground running* within hours of his appointment. George was

actively engaged in this initiative since his appointment and we are indeed fortunate to have a person of his standing leading this program.

With are now in the final stage of the pre-launch phase. The first targeted Charitable Gaming Centre to switch over is Valley Bingo Centre – Sudbury, at the end of August 2012. The operations leader of the Sudbury Bingo Group, Mr. Michael Orser, remains confident he [from an operations position] will be ready for the targeted date.

This will then trigger a host of other Charitable Gaming Centres moving over to 207:1:a in the next twelve months. It is going to create opportunity but it must be borne in mind this will also present us with a Cultural Change, which we must all embrace positively.

993 – Olympics 2012 – UK (London)

At the end of this week we will see the eyes of the world turn to the United Kingdom of Great Britain for the largest sporting event in the world, namely the Olympics 2012. During the course of the few weeks this event is held, it will certainly grab the attention of a vast number of the population and thus it has the potential to impact our trading.

I am sure you are prepared to weather this period as we have flagged it on numerous occasions in this newsletter. The suggestion by Mr. Michael Orser of creating an *Olympic lounge area* in the Gaming Centre seems the most effective way of accommodating our consumer's interest in the various events of the Olympics.
